#### POLAR BEAR IN A SNOWSTORM Rev. Amy Carol Webb

hat is this?" she said, holding up what appeared to be a blank white sheet of paper. While we thought this must be a trick question, it only turned out to be a tricky one. "Really," she insisted, "what do you see?"

Now, when we were kids the answer to the trick question was a cheeky, "A polar bear in a snowstorm!" which yet tends to delight grade school young'uns to this day.

On this afternoon however, the tricky question was asked of a room full of adults, committed to deeper understanding of - and greater resolve to combat - racism and systems of oppression of which the majority of us remained unaware.

"Um," a bolder person than I ventured a response, "... nothing?" The murmuring heard among us was not an expression of judgment of the answer or the answerer, but of relief the rest of us felt to not be scrutinized at the moment.

"Thank you for braving an answer," our guide replied, "but it's not nothing.... It's what white privilege looks like to white people."

Some of us gasped a little as it struck us.

"We don't see it, because we move through it, with it, in it from our first breath," she continued as a wave of equal parts awakening and resistance rolled over the

room. "And even when we do learn to see it, we too often still look for ways to justify it, or mollify ourselves in it ... or sometimes just plain deny it."

That was then. Today we are learning to haul ourselves and one another out from the institutional structures of privilege our very nation, our society, and our dominant culture are founded upon – and dare to call them what they are: systems of white supremacy.

It's not about guilt – it's about accountability – it's not about condemnation – it's about reformation. It's not about rescue – it's about redemption.

The exposure of inequitable hiring practices in the Unitarian Universalist Association in March has given us opportunity to answer the call to face ourselves, our history and our future. To more fully live the faith we profess, River of Grass joins with more than 600 UU congregations around the world to do a White Supremacy Teach-In on Sunday, May 28th.

It's hard to see a polar bear in a snowstorm. But we will keep working until we do. That the love we proclaim may prevail, and justice roll down as a living stream.

May 3 where he spent about 1<sup>1</sup>/<sub>2</sub> hours with us looking over the facility. Officer Elliott was friendly and forthright and an expert in assessing houses of worship. In fact, he provides many volunteer hours at his own church!

While the official report is not available yet, I will share some initial insights of interest to the congregation.

Internal security practices are important! There are several measures we've implemented but it's worthwhile to review a few of them here.

- In general, keep the back door locked. There are few exceptions to this practice.
- Secure the facility when departing. Is the office locked? The equipment cabinet? The back door?
- Keep doors free of obstruction. This is particularly challenging in the nursery and the door next to the AV desk.
- Follow money-handling guidance. It's not only good stewardship for the generous contributions, but keeps our funds more secure.

The officer had several ideas to help, some that will be simple or low-cost, others, of course, will be more costly. I look forward to his final report and will work with the board towards implementing what we find feasible and prudent. Once received, I will make the full report available on request.
